R Sonnenberg made a motion to approve the Treasurer's report. D Sonnenberg second. All in favor. Motion carried.

R Sonnenberg made a motion to approve the disbursements as presented. D Sonnenberg second. All in favor. Motion carried.

Gravel quotes were discussed. Considering availability of material, ease of access, quality of service and availability of service, D Sonnenberg made a motion to extend the present quote with Heisler's Country Gravel for a period of two years at the price listed in the 2014 quote. R Sonnenberg second. All in favor. Motion carried.

Mowing and brushing quotes were discussed. Considering the quality of work done in the past and the availability of getting the work done when the Supervisor's want the work done, D Sonnenberg made a motion to extend the current quote for a period of two years at the price listed in the 2014 quote. Hockett second. All in favor. Motion carried.

Approach permits for Blaine and Giefer were reviewed and approved with D Sonnenberg making the motion and R Sonnenberg seconding the motion. All in favor. Motion carried.

Kevin Mohn approached the Board regarding filling in a portion of the twp right of way to improve his lawn. R Sonnenberg stated that the Board had looked at the site last fall and saw no problem with the proposal. R Sonnenberg made a motion to approve the proposal. Hockett second. All in favor. Motion carried.

Dust control was discussed. Two quotes were received and reviewed. D Sonnenberg made a motion to accept the quote from Stenger's Dust Control due to the past history of good service and best price. R Sonnenberg second. All in favor. Motion carried.

Information was presented regarding a public road seminar coming up in later April to be held in Detroit Lakes.

Hockett stated that they are looking for a representative from the Township to assist in locating the bike and hiking trails in Hobart Township.

Discussion was held regarding rebuilding the public access to Jim Lake. R Sonnenberg made a motion to have Sonnenberg Excavating do the necessary work. Hockett second. All in favor. Motion carried.

Road tour is tentatively scheduled for April 20, 2016 at 1:00 p.m.

Since there was no further business to come before the Board, Hockett adjourned the meeting at 8:15 p.m.
